5. In the event of Photographer's illness or other unforeseen circumstance, Ideal Impressions Photography may substitute another competent, professional photographer. 6. The client will obtain full resolution digital files which may be used for announcements. Images may be used for personal use only, and may not be sold or published without our written consent.

6. The client win obtain that resolution digital messions Photography will remain with the falled Impressions Photography, our clients will obtain shared rights to use the images as named anotaccement.
